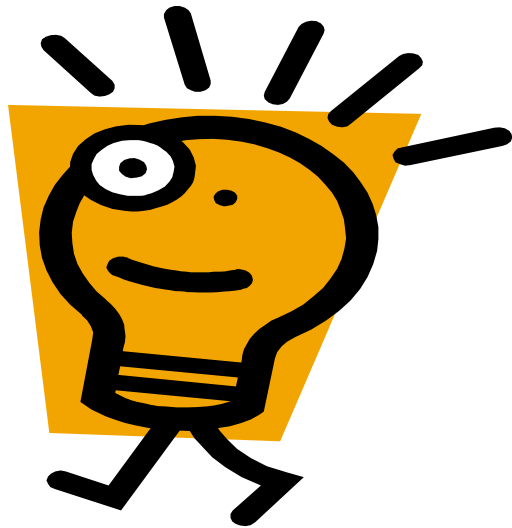

## Recomendaciones
